Rival Sons Covid-19 Protocols Fall 2021

<u>ALL VENUE STAFF MUST WEAR MASKS AT ALL TIMES, NO EXCEPTIONS.</u> Must be 3-ply medical or N/KN95. No neck gaiters, scarfs, bandanas will be permitted. Failure to do so will prompt the staff member's swift removal.

<u>Audience</u>

A full COVID-19 vaccination (J&J + 14 days or second dose of Pfizer/Moderna + 14 days) or a negative COVID-19 test (result presented within 48 hours prior to entry) will be required upon entrance to attend any Rival Sons event. For individuals not fully vaccinated, a negative test must be presented AND a mask worn over the nose and mouth at all times while onsite.

Employee Policy (Front Of House):

A full COVID-19 vaccination (J&J + 14 days or second dose of Pfizer/Moderna + 14 days) or a negative COVID-19 test (result presented within 48 hours prior to entry) will be required upon entrance to attend any Rival Sons event. For individuals not fully vaccinated, a negative test must be presented AND a mask worn over the nose and mouth at all times while onsite. All food and beverage handlers will be required to wear a mask over the nose and mouth and wear CLEAN gloves at all times. Gloves must be changed frequently. A photocopy of your vaccine card/record or of your negative COVID-19 test will be accepted.

Employee Policy (Back of House / Artist Dressing Rooms / Artist Catering / Stage Access)

All backstage and stage working staff must be vaccinated and tested before entering venue. A full COVID-19 vaccination (J&J + 14 days or second dose of Pfizer/Moderna + 14 days) will be required upon entrance into these areas. Individuals not fully vaccinated will **not** be allowed into these areas. A mask worn over the nose and mouth at all times while indoors and while near others, even outdoors. All food and beverage handlers will be required to wear a mask over the nose and mouth and wear CLEAN gloves at all times. A photocopy of your vaccine card will be accepted.

Support bands must be vaccinated and tested before entering venue.

You will be asked to complete a Daily Health Assessment and temperature check upon arrival by our touring Covid Compliance Officer. Anyone who displays or confirms they are experiencing symptoms or a temperature consistent with those of someone infected with COVID-19 (100.4 or higher), shall not be allowed entry into the venue. Your information will remain private.

Artist Dressing Rooms / Artist Catering / House Food & Beverage Areas:

We ask that all Dressing rooms and catering areas be cleaned and disinfected prior to artist arrival. We ask that no one outside of the band and crew be allowed in the dressing rooms following their initial sanitization. We ask that all Backstage Catering areas will be cleaned and sanitized with

increased frequency and between meals. As face coverings cannot be worn while eating, adequate eating space must be provided to ensure physical distancing can be maintained during meal periods. Eating utensils should be disposable and individually wrapped.

Signage & Venue Acknowledgment

Please have Covid-19 signage printed and posted at EVERY backstage entrance, including dressing rooms (mask required, do not enter if you have symptoms, etc.). We also **require** signage to be posted around the venue encouraging attendees to wear masks. If you need access to these resources, visit healtheducationservices.net or I can send them to you.

Venue **must** acknowledge that local crew has been advised as to all requirements and protocols.
